 - Need to take 80 hrs of French language training in China before departure, no requirement as to the level to achieve

 - Bachelor 3rd year or master, certificate from CUEB with the list of courses attended in the 1st semester
 - Motivation letter
 - Resume
 - Recommendation letter from English language teacher
 - Copy of passport/ID card
